# **PUBLIC OPINION**

Public opinion is the opinion of those sections of the community which think unorganized way on public problems and attempt to influence public policy by their opinion.

### **DEFINITION OF PUBLIC OPINION**

According to j.A.Corry: Opinion is to be defined as consisting of views on matters that are open to discussion a public opinion is one that determines on influences on may be expected to influence what government does. Isolated opinions held by one or a few persons have little immediate influence public opinion is a view relating to government held strongly enough by a considerable number of people to dispose them to put for action.

According to Lord Bryce: The term is commonly used to denote the aggregate Of views men hold regarding matters that affect or interest the community does understood it is a congeries of all sorts of discrepant notions ,beliefs, fancies prejudices and aspirations .

### IMPORTANCE OF PUBLIC OPINION IN DEMOCRACY

1. The success of democratic government depends upon the degree to which the public opinion is sound well developed and effective in controlling the actions and policies of government.
