General Instructions and Eligibility Criterion regarding the advertisements nos. Academic 1185 /01/2020, 1186 /02/2020 and 1187 /03/2020

GENERAL INSTRUCTIONS

- 1.1. Online Applications are invited from Indian citizens for appointment on the posts of Professors, Associate Professors and Assistant Professors in the University.
- 1.2. Advertisement is being issued in compliance of various Government Orders issued from time to time.
- 1.3. Separate application along with application fee should be submitted for each post applied for.
- 1.4. The prescribed application fee (Rs. 1000/- for UR, OBC & Rs. 750/- for SC & EWS candidates) for each position is to be paid online.
- 1.5. Application form, rules and regulations and other details are available on University website: <http://www.ccsuniversity.ac.in/ccsu/recruitment>
- 1.6. UR, SC, OBC and EWS indicate posts for Unreserved, Scheduled Castes, Other Backward Classes and Economically Weaker Section (other than SC/OBC) respectively.
- 1.7. Reservations will be applicable as per U.P. State Government norms/ rules (संख्या-5/2019/4/1/2002/का-2/2019टी.सी.1 लखनऊ, दिनांक: 13 अगस्त, 2019). OBC/SC/ST/EWS applicants of the states other than Uttar Pradesh would be treated as General Category candidates.
- 1.8. The SC/ ST/ OBC (non-creamy layer)/ and others getting relaxation in eligibility criterion are required to attach latest and online verifiable self-attested certificate(s) as prescribed by the Government of Uttar Pradesh.
- 1.9. The Reservation to EWS candidates shall be applicable as per Government of India, Ministry of Personnel, Public Grievances & Pensions, DOPT OM No. 36039/1/2019- Estt (Res) dated 31 January, 2019. The benefit of reservation under EWS can be availed upon the production of an Income and Asset Certificate (latest and verifiable) issued by competent authority, as per the above mentioned DOPT OM dt.31.1.2019.
- 1.10. Qualifications, pay scale and other conditions are according to the UGC Regulations on **Minimum Qualifications for Appointment of Teachers and Other Academic Staff in Universities and Colleges and Measures for the Maintenance of Standards in Higher Education 2018** dated 18 July 2018 and U.P. Govt. Notification dated 28 June 2019 (for University Teachers) and are subject to any future rules/regulations/norms/directives, including amendments in the present regulations, stipulated by the MHRD/UGC/any other Competent Authority and notified by Uttar Pradesh Government applicable to such recruitments which may change from time to time.
- 1.11. Mere eligibility will not entitle any candidate to be called for interview. The University reserves the right to restrict the candidates to be called for interview to a reasonable number (even fulfilling the eligibility criterion or securing higher academic score than the required score) according to the fix criterion/ specifications for screening/ shortlisting the applicants decided by the duly constituted Screening Committee(s) and approved by the competent authority.
- 1.12. Selections shall be based only on the performance in the interview and the criterion/ specifications fixed by the duly constituted Screening Committee(s) and approved by the competent authority.

1.13. Candidates working in Govt./Semi Govt./Public Sector Undertaking/Autonomous Institutions etc. are required to submit their applications (online and offline both) through proper channel along with 'No Objection Certificate' from the competent authority. If "No Objection Certificate" from the employer is not produced, the candidature of the candidate may not be considered even if otherwise eligible.

1.14. Candidates are required to submit an undertaking at the time of interview that:

- (i) No penalty has ever been imposed on the candidate and has never been convicted by any Court of Law.
- (ii) No Disciplinary action/ Vigilance case is pending or is contemplated, against him/her.

1.15. Incomplete Applications or Applications without attested copies of the relevant Certificates and Experience and No Objection Certificates (if applicable) or Applications not in prescribed Proforma shall not be entertained.

1.16. The University reserves the right (without assigning any reason thereof)

- (i) to increase or decrease the number of positions in any of the advertisement even at the time of interview/ selection
- (ii) to withdraw the advertisement either partly or fully at any time
- (iii) to suspend/ cancel/ terminate the recruitment process
- (iv) to alter/ insert any corrections/ additions in the advertisements on the website, if required, before the last date prescribed for the receipt of Application
- (v) to cancel any communication (even appointment letter) made to the candidate, in case of detection of an inadvertent mistake in the process of recruitment, detected at any stage.

1.17. Submit the printout of the online filled Application Form duly completed in all respects along with original signature and self-attested documents by speed post or registered post only to the **Registrar, Chaudhary Charan Singh University, Meerut (U.P.) – 250004, India on or before 27 /04/ 2020.**
