TASK GROUP FOR INTERNATIONAL COOPERATION POLICY



PREAMBLE

International cooperation is necessary for bringing social, cultural and scientific benefits to humanity. The International Cooperation Policy (InCoP) for higher education and research would have the potential to address several challenges/limitations and pave the path of diverse perceptions for the costs/benefits of the collective action. The Memorandum Of Understanding (MOU) remains the primary national/international forum for any exchange program of academic/R&D and negotiations. The InCoP would have full rights at institutional levels and emerge at global, regional, national, local, as well as public-private initiatives or start-ups networks. The institutional diversity arises in part/full for growing the academic/R&D/innovation programs and make policies arenas, for example, the sustainable development, international trade, and human rights. The InCoP is a link to create opportunities, potential co-benefits, or harms that have not yet been thoroughly examined. This forum creates the possibility of nurturing new brain and increased negotiation of collaboration, which could open new avenues for the performance of international cooperation toward sustainable development goals (SDGs).

The centralized formalization spans would have the strong multilateral agreements (cultural, commercial, academic, R&D) to be harmonized national/international and coordinated policies. The mutual and potential agreements vary in their degree of legal bindingness for design elements of international agreements for particular relevance: goals and targets, flexible mechanisms, and equitable methods for effort sharing. Efforts continues to develop institutions and systems for governance/coalitions of private businesses of international cooperation on innovation. These forums and coalitions address issues including technology transfer, adaptation, and sustainable systems.

ARTICLE 1: INTRODUCTION & OBJECTIVE(S)

Universities provide education that builds skills across many fields needed to build a wellfunctioning economy and society. The final draft of National Education Policy (NEP 2020) laid down the objective of Internationalisation with the objective to offer students study at abroad, in part or full. The credit gained by the students can be transferred to university or vice-versa. It aims to promote facilities to the foreign students to take up courses in Indian Universities. It read as "India will be promoted as a global study destination providing premium education at affordable cost thereby helping to restore its role as a Vishva Guru" (NEP 2020, 12.8, p29).

The international cooperation is necessary to significantly alleviate the cooperation impacts for the next generation of the society. The executive committee will critically examine and evaluate the ways of agreements for international cooperation/collaboration and address for the implementation upon the evidence and insights in the scholarly literature. The reflective analysis for the international cooperation will be quantified (type of the cooperation or collaboration in terms of exchange programs for students of their innovative learning).

The major objectives are outlined as:

- 1) Visits and informal exchanges of faculty, scholars and administrators in specific areas of education, research and outreach.
- 2) Explore ways to cooperate in postgraduate education and training.
- Organize joint conferences, symposia, or other scientific meetings on subjects of mutual interest.
- 4) Exchange and access of academic information and materials.
- Pursue avenues for graduate and professional student exchange during the academic year or summer terms.
- Pursue avenues for undergraduate student exchange during the academic year or summer terms.
- 7) Explore the possibilities for developing joint research programs and collaborations.
- 8) Establish modules of the research enterprise (i.e. centre of excellence, international student cell, international campus, etc.)
- 9) Other exchange and cooperation programs to which both parties agree.

ARTICLE 2: BACKGROUND

India is a country with a fine knowledge legacy and a place that has truly world-class university spaces which attracts the best in the world. Chaudhary Charan Singh University, Meerut, located in western Uttar Pradesh, is one such premier educational institutions of the country. The Chaudhary Charan Singh (CCS) University was established in 1965 that needs to cater the higher education in Uttar Pradesh, India. This premier State Government institute sprawls over 222 acres area of beautiful and pollution-free green campus fully covered with wi-fi facility, power back-up facility for 24x7 with solar power (green energy), botanical garden, gymnasium, playground, indoor stadium, well equipped library, hostels for both girls and boys, administrative block, spacious auditorium, community centre, medical centre, residential quarters for faculty members and employees, canteen, post office & bank facility, and Indian railway reservation counter. There are 36 departments including Natural & Agriculture Sciences, IT & Engineering, Linguistics & Management, Humanities & Mass Communication, Physical Education & Fine Arts, Legal Philosophical studies, and well-equipped laboratories & advanced facilities for more over 500,000 students. The university is offering a large number of new and innovative post-graduate & undergraduate Degrees, diploma, advanced diploma and postgraduate diploma and Doctoral degrees. The academic program exposes the students to practical aspects through computer labs, seminars, group discussions and lectures of experts invited from National/International recognised Institutes/Universities/Industries all over the world. The recognition of the university is due to efforts of well-qualified and committed faculty members who have been providing quality education to postgraduate, and Ph.D. Scholars. The University has also made a mark in the field of sports, where the trained students have participated in Asian/Commonwealth/Olympiad games. The research activities in various departments are supported by grants in the form of research projects sanctioned by the R&D agencies and from own sources.

The University has launched International Cooperation Program wherein students of diverse backgrounds from all over the world can take admissions in the courses of their choice, offered by the university.

a) MOU

A Centre for International Cooperation has already been established in the University wherein several MOU with other International reputed universities and institutions have been signed. The following MOU are still active:

These MOUs are focussed on joint conduct of research work with faculty and student exchange options. Such ongoing MOU will continue in force till completion of such MOUs. Now, the draft of International Cooperation Policy has been formulated keeping National Education Policy 2020 in view and as well as to have an International indelible mark on the world education.

b) Promotion of books and research papers publication: The faculty members have already published joint research papers either in collaboration through MOUs or through themselves. Hence, this policy will further strengthen the joint publications.

c) Exchange of resources: Some of the faculty members are already utilising the laboratory facilities of reputed organisations by either sending samples for testing or analysis of results etc. The faculty from abroad has visited our university under various schemes such as – Indo-US, Indo-German, Indo-Canada. The different faculty members have already visited reputed organisations as an exchange under different categories of MOU, Common Wealth, Raman Fellowship, DAAD fellowship, NSERC fellowship etc.

d) Exchange of students: Some of the students have been sent to reputed International Research Organisations for conduct of their research work, fellowships etc.

e) Collaborative research: The faculty members are already conducting joint research in collaboration with different organisations and the output includes patents, research papers, seminars, workshops. A research project was also sanctioned by Tokyo University of Science, Japan to Department of Chemistry. Invited lectures were organised at both the places and a joint workshop was also organised.

ARTICLE 3: ESTABLISHMENT OF INTERNATIONAL STUDENT CELL

In order to promote the International Educational hub for welcoming students from foreign nations, an 'International Student cell' is to be established. The purpose of the cell is to lay down guidelines for admission and to facilitate required facilities to the foreign students such as hostel, visa, eligibility, admission procedure, verification of documents, transfer of credits etc. The International Cell will provide transcript of degree, marksheet to the students who aim to take up courses in the foreign universities. Every effort will be made to make degree/Marksheet available in the Digi-locker for immediate help of the students. This Digi-locker will be used for verification of the document also.

Our university has international reputed faculty members and offer courses with curriculum matching with the courses offered by international organisations. We have State-of-Art laboratories which can be used in conducting short term and long-term curriculum program for faculty.

Promotion of Indian knowledge System: India has multiple linguistic culture related to food, dance, music, language, health, knowledge. Our university can offer short term and long-term

courses related to cooking, textile, dance, music, vedic maths, architecture, hindi language and sanskrit language.

ARTICLE 4: CREDIT TRANSFER & AWARD OF DEGREE

The NEP 2020 has provision for establishment of academic bank of credit. The students will be credited their credit against their account. These credits can be gained for students taking courses in the foreign University and similarly the students who shall visit our University or affiliated colleges can also be credited to his/her account. Such students can use their credits at their convenience for the award of the degree. Every student has provision for award of certificate/diploma/degree on gaining minimum number of required credits. So, students are free to opt for certificate/diploma/degree or transfer of degree as per their credits.

ARTICLE 5: FINANCIAL & INFRASTRUCTURAL SUPPORT

The university will provide the required infrastructure and financial support for promotion of all the activities of international collaboration. It is expected to establish a foreign studentteacher hostel (with kitchen) and infrastructural facilities. The foreign students can make use of laboratory and research facilities at par to our students.

The foreign students can be offered scholarship/ financial support as per the discretion of the International Student Advisor. The financial support can also be given in kind such as books, study material etc.

Our university faculty members and students can be provided financial assistance for attending lectures, conferences, workshops. The provision can also be made for supporting Joint Research Projects in form of instruments, faculty & student exchange, joint publications, Patents etc. The provision may be made in university annual budget for allocation of certain funds for promoting international collaborations.

ARTICLE 6: CONDUCTING AWARENESS PROGRAMS

It is essentially required to promote awareness of the academic and research program offered by our university. It is suggested to hold and participate in education fair in India and

abroad. A very interactive website needs to be developed wherein all the information related to curriculum, admission procedure, facilities, environment, interaction procedure, etc. will be provided.

ARTICLE 7: ESTABLISHMENT OF RESEARCH & ACADEMIC CAMPUS ABROAD

Different foreign universities are opening their campus in Indian Universities and in Asia region. It will be appropriate and well required to establish our research and academic campus in foreign countries. The preference may be given to MOU signing research organisations and institutions.


